



Leamington Federation Sydenham Primary School and Lighthorne Heath Primary School Internet Access Policy Statement

Aims:

- To promote responsible use of the Internet in school.
- To prevent misuse of the technology available in school.
- To avoid children being vulnerable to unsolicited and inappropriate communications from other people.
- To prevent children having access to web sites with explicit content, such as pornography, misuse of drugs, promotion of violence, intolerance, racism and extreme political and social views

Processes:

- Children will have access to a filtered Internet service at school. This filtered service will take steps to ensure that the children do not have access to inappropriate web sites.
- Internet access will be directly controlled by an adult working with infant and some junior children.
- The issue of copyright will be discussed with children and they will be encouraged to acknowledge sources.
- Teachers will investigate the nature of the different media and the difficulties that pupils may
 experience with retrieval and in dealing with large quantities of information. Teachers will structure
 research involving the use of search engines, and pupils will be taught the necessary information
 handling skills.
- Pupils will be encouraged to tell a teacher should they feel uncomfortable or threatened by messages received or material seen.
- Teachers will review the contribution made by Internet use to teaching and learning, within the curriculum planning process.
- Children will have the opportunity to communicate easily with other people around the world by electronic mail. Children will be able to send and receive e-mail to a class e-mail address. The content of e-mail sent and received will be screened and monitored by the class teacher.
- Wherever pupils interact with the public by e-mail or web site, particular care will be taken to ensure that the communication is appropriate. Pupils will be given specific guidelines for personal safety:
 - 1. Never give your full name
 - 2. Never give out a home address
 - 3. Never give out a telephone number
- The school will control the quality and presentation of material on its school website. The school will
 not publish photographs with pupils' names on the website. The school will seek parental consent before
 publishing photographs of children on the school website.
- The LA will occasionally monitor files or sites visited by the school.
- Parental permission will be sought before pupils are allowed Internet access.
